Navigated Brain Therapy (NBT) requires an MRI scan of the patient for the neuronavigation targeting system. It allows for accurate real time navigation of the TMS directly to the DLPFC, however it requires a \$50 disposable head tracker for each use. Also the MRIs may be costly.
